Inhalation.

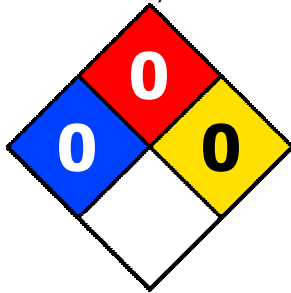
